



CHARLESTON WEST VIRGINIA REPORT

SECAC met for the first time in its 65 years in the mountain state's capital, October 17-20, 2007. Marshall University and West Virginia University co-hosted. The welcome reception was held Wednesday evening under the magnificent dome of the West Virginia Capitol building, designed by Cass Gilbert, and completed in 1934. After sessions and meetings on Thursday, members were treated to exhibits and receptions at the Clay Center for the Arts and Sciences and at the Marshall University Graduate College. Nearly 300 members attended Friday's SECAC Awards Luncheon. Past conference chairs and the Gulnar Bosch Travel Award recipients were recognized before the awards were announced. '37 Flood, a Huntington Bluegrass band, provided entertainment.

Friday evening events were in the West Virginia Cultural Center, and included a solo exhibition of the 2006 Artist's Fellowship winner Barry Freedland, the Member's Exhibition, and a memorable keynote address by artist Willie Cole. Tours to Blenko Glass and the Huntington Museum of Art, an architectural tour of Charleston, and a tour of the West Virginia State Capitol, and a reception and exhibit of West Virginia artists in the Charleston City Hall rounded out events on Saturday. 364 members attended, and 41 of those were student members; 250 presenters, and of those, 40% were from outside the traditional SECAC area. Also attending were a number of Marshall University and West Virginia University students. Wild, Wonderful, West Virginia was warm and welcoming to us all. Thanks go to conference chair Don Van Horn of Marshall University, and the support of many at Marshall University and West Virginia University.

THE 2007 SECAC AWARDS

The SECAC Award for Excellence in Teaching was presented to three members: **Lauren Garber Lake**, of the University of Florida, **Reni Gower**, of Virginia Commonwealth University, and **Andrew Ladis**, University of Georgia.

One juror noted of Lake, the obvious enthusiasm, energy and inventiveness of her teaching and the wide range of her pedagogical approaches, commenting "the letters in support of her application were impressive in the level of detail and the heartfelt nature of her support." Professor Garber Lake's development of projects that united Gainesville's community of artists, students and small business owners to benefit victims of the December 2004 tsunami and Hurricane Katrina were also lauded.

Professor Gower's nominations materials were "most impressive and her peer and student evaluations support the excellence of her instruction." She has directed or served on seventy-five thesis committees and has been invited to be a visiting artists at six major universities. The SECAC teaching award joins several VCU faculty grants for Reni Gower's teaching excellence.

Jurors were "swayed by the strength and fervor of the student testimonials concerning the long-lasting and far-reaching impact of Andrew Ladis's teaching. From all accounts his approach to teaching is truly inspirational. Students emphasize his humane approach and the sense of respect he accords them." Professor Ladis is "an eloquent speaker, who understands the power of words in shaping the aesthetic abilities of his audience. His passionate love of this material is obvious and persuasive; several of the students seem to have undergone a 'born again' experience in his classroom."

The SECAC Award for Excellence in Scholarly Research and Publication went to **Amy Kirschke**, University of North Carolina at Wilmington for: *Art in Crisis: W.E.B Du Bois and the Struggle for African American Identity and Memory*, Indiana University Press, 2006. Professor Kirschke's book was a solid piece of research that weaves art history, history, social science and political history to examine the role of W.E. B. Du Bois, editor of *The Crisis* magazine, in defining African American Identity and in exposing insistent discrimination and racism.

The SECAC Award for Outstanding Artistic Achievement went to **Suzanne Jackson**, of the Savannah College of Art and Design. Professor Jackson was recognized based on the length and breadth of her career, her numerous exhibition venues (ranging from California to Savannah since 1968), the critical appraisal of her work and her lifetime of

sustained creative practice. In nominating Jackson for this award, her colleague Sandra Reed described the artist's large works on paper, ranging from monoprints to two-sided "tapestries," as strong, dimensional and textural, willfully incorporating sections of earlier works. As William Zimmer noted, Jackson "revivifies and validates in her own way the discounted notion of painterly uniqueness."

SECAC Award for Outstanding Exhibition and Catalogue of Historical Materials recognized **Ashley Callahan**, *Modern Threads: Fashion and Art* by Mariska Karasz, Georgia Museum of Art, 2007, William U. Eiland, director.

SECAC Award for Outstanding Exhibition and Catalogue of Contemporary Materials was given to **Dennis Harper** and **Paul Manoguerra** for *Weaving His Art on Golden Looms: Paintings and Drawings* by Art Rosenbaum, Georgia Museum of Art, 2007, William U. Eiland, director.

In addition to these professional achievement awards, SECAC also presents upon occasion, special awards designated by the president. The **SECAC Certificate of Merit** is presented to members of long and true standing who have entered into retirement. This year's recipient was **Charles R. (Randy) Mack**, Professor Emeritus, University of South Carolina.

SECAC Award for Exemplary Achievement goes to **Charles R. (Randy) Mack**, Professor Emeritus, University of South Carolina and **Pamela Simpson**, Washington and Lee University. Both have served as officers in SECAC and they both continue to contribute to its growth and vitality.

Jurors for the 2007 Awards were: Stephen Driver, Brescia University; Gary Keown, Southeastern Louisiana State University, Scott Karakas, Florida Gulf Coast University; Charles R. Mack, SECAC Past President and University of South Carolina, Emeritus; Elise Smith, Millsaps College; and Debra Murphy, SECAC 1st Vice-President and University of North Florida, chaired the committee.

2007 ARTIST'S FELLOWSHIP RECIPIENT ANNOUNCED

Pat Wasserboehr, Administrator of the SECAC Artist's Fellowship, announced that from 56 applications, a committee of three jurors selected **Jason Lee** of **West Virginia University** as the 2007 recipient of the \$3000 award. The jurors for the artist's fellowship were Michael Aurbach, Vanderbilt University, Alison Helm, West Virginia University, and Andrea Wheless, High Point University. Lee will plan and prepare an exhibition of his sculpture for the New Orleans at the 2008 conference and an interview published in the *SECAC Review*.

Lee received his MFA in Sculpture from the University of Wisconsin-Madison in 1998.

Currently, he is an Assistant Professor and Foundations Coordinator at West Virginia University. Lee constructs seamlessly crafted containers with light boxes inserted inside and arranges them in multiples. The boxes display photographic images of idealized suburban landscapes. The artist intends to question the perceived safety and security of these settings at the expense of what he defines as real experience. For Lee, the SECAC Artist's

Fellowship will assist to defray the expenses of twelve additional modular landscape installations measuring 4'H. X 2' W. X 2'D.

Lee has exhibited in regional and national exhibitions. Recent group exhibitions have been installed at The Albright-Knox Gallery, Buffalo, New York, Gallery 324, Cleveland, Ohio, and the Reinberger Gallery, The Cleveland Institute of Art, and at the Cleveland Museum of Art, Cleveland, Ohio.

NEXT YEAR—NEW ORLEANS, LOUISIANA

SECAC will meet **September 24-27, 2008 (note the earlier than normal date!)** in New Orleans, Louisiana. This is the third annual meeting to be held there, and the first since the devastation wrought by Hurricane Katrina. The University of New Orleans is hosting the conference that will be held at the New Orleans Marriott at the Convention Center. This hotel is located across the street from the Morial Convention Center and in the heart of the city's arts district (including the acclaimed National WWII Museum) and within walking distance of the French Quarter. On-site parking is provided for a fee, and there is shuttle bus service (also for a fee) to and from Louis Armstrong International airport.

The planning committee is continuing to work on the details for this meeting. An eminent keynote speaker, two receptions and tours of the French Quarter, the Garden District and the Arts/Warehouse District, in addition to a visit to Mardi Gras World to capture some of the flavor of the city's most famous holiday, will complement the traditional SECAC program. New Orleans itself is an extraordinarily rich and diverse city, even after the storm. Conference goers will have opportunities to explore its culture—culinary, musical and artistic—both in groups and individually. Our art institutions—the New Orleans Museum of Art, the UNO/Ogden Museum of Southern Art, the Contemporary Art Center and the Historic New Orleans Collection—will all be available to SECAC members, and we are also planning a Saturday afternoon open house at the commercial galleries on Julia Street and in the surrounding arts district.

The 11th Annual SECAC Members' Exhibition will be held at the UNO/Ogden Museum of Southern Art that will also host a reception for the show's opening on Thursday night. The Ogden Museum, a Smithsonian affiliate, has an extensive collection of Louisiana historical art and contemporary works by artists from across the southeast. The reception there will give members a wonderful taste of traditional New Orleans cuisine.

New Orleans is recovering slowly from the effects of Katrina. The city's arts community has come back with a vengeance, though, and is as active and vital as it has ever been. The arts district will make a wonderful backdrop to what promises to be a busy and stimulating annual meeting. Y'all come, hear!

ANNUAL BUSINESS MEETING

Some of the matter that came before the Membership Meeting are reported elsewhere in this Newsletter, and will not be repeated here. Significant action is reported below. Minutes of the 2007 Board and Membership Meetings are posted on the SECAC website.

President Don Van Horn opened the meeting by recognizing new board members: Jane Hetherington Brown (AR); Lealan Swanson (MS) [represented by her colleague Christopher Gauthier]; Scott Karakas (FL); Larry Ligo (NC). Directors elected to their second terms: Carol Crown (TN); Helen Langa (At-Large); Beth Mulvaney, re-elected as Secretary-Treasurer; and Debra Ambush, the new FATE representative.

A budget for 2008 was adopted that includes maximum conference registration rates of \$140 Early Bird, and \$180 Late Registration; enrolled student students \$45 Early Bird and \$60 Late Registration. The membership also approved a conference policy of offering one-half price registration to retired SECAC members.

I think we can maintain those essential qualities of SECAC that make us the organization we are while expanding our mission. But, we have to make informed decisions about how we manage the affairs of SECAC and how we continue to serve our many and varied constituencies. SECAC is a powerful force in higher education and we need to chart a course that will capitalize on our strengths.

Lastly, I want to focus some of my attention over the next year on securing additional conference hosts for our annual meeting. New Business: Two new lines appear in the budget, one for liability insurance, and one for tax preparation. Gulnar Bosch Student Awards: both students who are presenting and exhibiting will now be eligible for the awards. These awards will now be a line item in the conference budget.

A competition for a SECAC website redesign will be held through members' courses. Winner to be announce in December 2008.

NEWS OF MEMBERS

Anna Fariello recently presented two workshops at the semi-annual meeting of the western North Carolina group, Museums in Partnership. Fariello, who teaches museum courses at Western Carolina University, presented workshops on Exhibition Planning and Digital Exhibits. And Western Carolina University received a third year of funding for its online digital exhibit, *Craft Revival: Shaping Western North Carolina Past and Present*. Selecting objects and documents from its partner institutions, project curator Fariello is scripting the history of a movement that helped position handcraft production on the national stage. Overall project funding, from the North Carolina State Library, totaled \$350,000. The online exhibit can be viewed at <http://craftrevival.wcu.edu>.

John Myers will be working with the Randall Library staff at the University of North Carolina at Wilmington, using a North Carolina Humanities Grant to create an online archive of art in Wilmington and the Lower Cape Fear, write a brief history of art in the region from about 1970 to the present, and to help collect materials for the archives that will be available online as a repository for research. He began phased retirement this year.

Jane Nodine, professor of Art and Gallery Director at the University of South Carolina Upstate, has been selected for the Medical University of South Carolina Ashley River Tower Contemporary Carolina Collection located in Charleston, SC. Slated to be the largest collection of contemporary art in South Carolina, over two hundred artists from across the state submitted works for consideration and of that group. Nodine was the only artist from Spartanburg to be included. Ten of Nodine's recent encaustic paintings were selected by the acquisitions team that was directed by Consulting Curator Mark Sloan, Director of the Halsey Institute of Contemporary Art at the College of Charleston. The works will be installed in the new Tower that will open in early 2008.

Paul Niell is publishing an article entitled, "No Town of Its Class in Spain: Civic Architecture and Colonial Social Formation in Sixteenth-Century Santo Domingo." The article will appear in the inaugural issue (Spring 2008) of *Hemisphere: A Journal of Visual Cultures of the Americas*, published by the Graduate Art Association at the University of New Mexico.

Robert Craig has been appointed architecture editor for Oxford University Press's *The Grove Encyclopedia of American Art*.

Victoria Fergus, West Virginia University received the Higher Education Division Educator of the Year Award at the WVAEA conference in Parkersburg, WV, October 12, 2007, at the Awards Banquet.

Documentation of **Cindy Rehm's** performance project, "Echo", was published in *Performance Research*, and one of her drawings was published in *Learning to Love You More*.

Donald Furst, University of North Carolina at Wilmington, won the 2007 North Carolina Arts Council Artist's Fellowship \$8,000. He received the Purchase Award for the 75-print edition of mezzotint "Down and Out" at the Premi Acqui international print exhibit in Italy. He was an invited exhibitor of mezzotint prints in the World Print Triennial, Prague; the Los Angeles Printmaking Society National Exhibition, Riverside Museum; and Prints U.S.A. 2007, in Springfield (Missouri) Art Museum.

Kate Kretz's work is included in "Pricked: Extreme Embroidery" at the Museum of Arts & Design in New York through Feb 2008, and "Just A Ghostly Paper Sigh", at 31 Grand Gallery in New York. Her paintings will also be shown at Art Miami and Chelsea Galleria (Miami) in December.

Erinn M. Cox just participated in the Open Engagement: Art After Aesthetic Distance Conference in Regina, Saskatchewan (Canada) where she delivered a paper titled "Memento Mori: Art of the Experiential Body" and participated in a group exhibition of where she presented her piece titled "The Family Jewels". Erinn is currently working in Chicago, IL with SOFA (Sculptural Objects / Functional Art), has been accepted into the Vermont Studio Center Residency for 2008, and will participate in her second international exhibition in Budapest, Hungary, in August of 2008.

A solo exhibit of **Diane Fox's** photographic work "UnNatural History," was shown at the Erie Art Museum, Erie PA this summer. The exhibit will be on display in SUNY Brockport's Tower Fine Arts Gallery, from Nov. 3, through Dec 9. Pieces from the exhibit were also selected for the SECAC Member's Exhibit in Charleston, WV and The Red Clay Survey in the Huntsville Museum of Art in Huntsville, AL. Fox was recently awarded a Faculty Enhancement Grant from UT College of Architecture to photograph in the natural history museums in London and Paris.

Anthony Fontana, Bowling Green State University, recently exhibited his animation, "Machinima Paradiso" at The Gallery Project in Ann Arbor, MI, and at the International Digital Media & Arts Association exhibit, 'IDEAs', in Philadelphia. As an administrator of the BGSU Second Life Virtual Campus and facilitator of a Second Life Learning Community in the Ohio Learning Network he is currently researching the potential for virtual worlds in art related pedagogy. All five presentations were accompanied by exhibitions of work—historical photographs of Winchester, the Valley Pike, Harpers Ferry and Natural Bridge for the art history lectures, and Dr. Kiefer's own drawings and collages for the art lectures. Her art was also exhibited in the juried *2007 Nancy Rodig Regional Exhibit*, The Arts Centre, Martinsburg, WV; the *Sixth Annual Blandy Sketch Group Show*, Boyce, VA; the juried *Art at the Mill Fall 2007*, Millwood, VA; and the juried Potomac Valley Arts Festival, Shepherdstown, WV. Dr. Kiefer also served as creator and chair of the panel, "Mapping and Territorialization from Terra Firma to Terra Incognita: Surfaces, Slippages, Projections, Intersections," at the SECAC Annual Meeting in Charleston, WV.

Marc Moulton's stainless steel sculpture, "Garden", has been selected by jury for inclusion into Sculpture Walk 2007, the premier opening for what will become an annual outdoor, city-walk exhibition held in Columbus, Georgia. He received the 2007 National Art Education Foundation Research Grant to support "Developing a Bundled Visual Arts Assessment." Exhibitions: *Mostly Now, Some Then: Tom Brewer*, New Smyrna Beach, FL; *A Twist on Tradition*, Artisans Center of Virginia.

A longer version of the paper **Nancy Palm** presented at this year's conference in Charleston, "Native Roots in the National Landscape: Thomas Cole's Indian Iconography and the Construction of American Identity," was recently published in *Shifting Borders* (Cambridge Scholars Press, 2007), an anthology of essays that examine the role of visual culture in illustrating the shifting definition of borders away from static dividing lines towards dynamic populated spaces: unstable elements which are continuously renegotiated by political, economic, and cultural factors. For this essay, she was awarded the 2006 Virginia LaFollette Gunderson Award for the best graduate student essay in American Studies at Indiana University.

Steven Bleicher, Coastal Carolina University, had a one-person show at the Southeastern Community College in Whiteville, NC.

New on the VRA website: <http://www.vraweb.org>: VRA Core 4.0, which is a data standard for the cultural heritage community; Digital Image Rights Computator program, which is intended to assist the user in assessing the intellectual property status of a specific image documenting a work of art, a designed object, or a portion of the built environment; Professional Status Survey Report, which reflects data gathered by the 2006-07 Survey conducted by the VRA.

VRA News briefs:

James Madison University received an IMLS National Leadership Grant for Libraries in 2006 to research and develop an application-programming interface (API) to facilitate interoperability between the Madison Digital Image Database system (MDID <http://mdid.org>) and other digital image systems and tools. During the research phase of the grant, JMU evaluated a wide variety of digital image systems and tools in order to identify useful endpoints for connecting to MDID. Along with these systems and tools, the survey examined the protocols, specifications, standards, and interfaces that facilitate high-level data exchange between systems and tools. It also considered the metadata standards used in the surveyed systems, tools and data exchange mechanisms; as well as investigated Web 2.0 applications and services, including online photo and video sharing websites. While the survey encompassed a wide range of existing digital systems and tools, it focused on the systems and tools used in teaching and scholarship. Three popular

candidates for integration with MDID were identified: ARTstor, PowerPoint, and Blackboard. Where feasible, the design of the MDID API will accommodate integration with these candidates. During the final year of the grant, the API will be designed, tested and results published in 2008.

The jointly sponsored ARLIS/VRA Summer Educational Institute will be held the week of July 7-13, 2008 at James Madison University in Harrisonburg, Virginia. SEI is intended to provide a

standardized and sustainable program for visual resources training, with a focus on issues related to the transition from analog to digital collections. It is open to professionals, para-professionals, and graduate level students in visual resources, library science, the fine arts, related humanities fields, and other image information disciplines.
